CSBG NFTWORK PARTICIPANTS

The North Dakota State Office administers CSBG funds to 7 Community Action Agencies in 100% of ND counties

68% of families served by the CSBG Network lived below 100% of the Federal Poverty Guidelines

38% of families served in ND were in severe poverty, below 50% of the Federal Poverty Guidelines

In North Dakota, Community Action Agencies provided services to 24,564 low-income individuals.



Nationally, of the **6.9 million families** served by the CSBG Network, **71.43**% were living below 100% of the Federal Poverty Guidelines.

Nationally, over 1,000 Community Action Agencies receiving CSBG funding provided services to 15.9 million individuals with low-incomes.

CSBG NETWORK RESOURCES

For every \$1 of CSBG, the ND Network leveraged \$6.91 from federal, state, local, and private sources, including the value of volunteer hours*



\$3,241,783 in CSBG funds were allocated in support of local entities in North Dakota.

The ND Network's non-CSBG funding totaled \$22,409,109.

CSBG PERFORMANCE OUTCOMES FOR NORTH DAKOTA

Services and strategies provided by the ND Network resulted in 83,062 outcomes for participants and communities with low incomes.

Outcomes Include:	
7,228	Employment
	Participants with low incomes in CSBG Network employment initiatives obtained supports which reduced or eliminated barriers to initial or continuous employment, acquired a job, increased their income, or achieved "living wage" employment and benefits.
1,461	Economic Asset Enhancement and Utilization
	Households with low incomes increased their financial assets or financial skills.
19,942	Child and Family Development
	Infants, children, youth, parents, and other adults participated in developmental or enrichment programs facilitated by the CSBG Network and achieved program goals.
5,095	Independent Living for Vulnerable Populations with Low Incomes
	Vulnerable individuals with low incomes received services from the CSBG Network and secured or maintained an independent living situation as a result.
4,796	Family Stability
	Participants with low incomes obtained supports which reduced or eliminated barriers to family stability through assistance from the CSBG Network.
40,308	Emergency Assistance
	Individuals and families with low incomes received emergency assistance from the CSBG Network.
2,552	Community Opportunities and Resources
	Community opportunities or resources were improved or expanded for people with low incomes as a result of CSBG Network projects or initiatives, or partnerships with other public and private agencies.
1,680	Community Empowerment
	Community members and people with low incomes mobilized to engage in activities that support and promote their own well-being and that of their community as a result of CSBG Network initiatives through maximum feasible participation.
